U.S. Gulf of Mexico shrimp fishery enters certification process: Culmination of 15 years of fishery improvement work

The American Shrimp Processors Association has entered the U.S. Gulf of Mexico shrimp fishery into sustainability assessments under the Marine Stewardship Council (MSC) and Certified Seafood Collaborative (CSC) Responsible Fisheries Management (RFM) certification programs. This step demonstrates concrete progress in resolving challenges in the fishery, including high rates of bycatch and interaction with seafloor habitat, that began 15 years ago with fishery improvement projects (FIPs) initiated by SFP.



Beginning in 2014, SFP initiated transition of state-specific FIPs to industry leadership. SFP now facilitates the U.S. Gulf of Mexico Shrimp Supply Chain Roundtable, to bring together leading shrimp processors and distributors in a pre-competitive environment to address overarching issues in the Gulf of Mexico.

Peru empowers small-scale fishers by enabling fisher registration for cooperatives

The government of Peru issued an historic decree to enable fisher registration by cooperatives in the mahi-mahi and jumbo flying squid fisheries, two of the most globally significant artisanal fisheries in the world. This decree removes the barriers for more than 900 artisanal vessels in major fisher organizations to be able to operate legally in Peruvian waters.

2022 Reduction Report shows ups and downs in performance of key fisheries

The 13th edition of our Reduction Fisheries Management and Stock Status Sustainability Review highlights both good and bad news for reduction fisheries compared to 2021. The majority of fisheries assessed continue to be reasonably well-managed or better, but concerns remain that overall performance has been stalled since 2018. Blake Lee-Harwood leaves SFP

SFP and Aquaculture Stewardship Council join forces to enhance aquaculture production


SFP Chief Executive Officer Jim Cannon and Aquaculture
