

Philippines Responsible Seafood Summit champions responsible seafood sourcing

More than 200 representatives from government, industry, and civil society came together at the first Responsible Seafood Summit, to discuss responsible seafood sourcing (RSS) and how to combat illegal, unreported, and unregulated fishing in the Philippines. The summit, which was hosted by the US Agency for International Development (USAID) Fish Right Program also included a celebration of industry partnerships developed under the Better Seafood Philippines (BSP) program, which is led by SFP and supported by USAID.

New resource will help identify human rights risks in seafood supply chains

An op-ed by SFP Global Policy Director Brad Spear and Aquaculture Stewardship Council CEO Chris Ninnes urges action by seafood companies to prevent human rights violations in the seafood supply chain and support individuals and communities involved in seafood production.



The piece was published in conjunction with the release of a new social component of the Certification & Ratings Collaboration's Sustainable Seafood Data Tool, which consolidates data on human rights abuses and risks in 92 seafood-producing countries. Engaging artisanal fishers in RFMO discussions improves fisheries management

New science by SFP, published in Ocean & Coastal Management, finds that engaging resource users in regional fisheries management organization (RFMO) governance can help RFMOs more effectively meet their objectives. The study looked at the impact of CALAMASUR (the Committee for the Sustainable Management of the Jumbo Flying Squid in the South Pacific) in influencing and advancing squid management decisions by the South Pacific RFMO.





Sector reports highlight seafood sector

production, trade, and sustainability







SFP's science team released three new reports this quarter as part of our <u>ongoing</u> series of sector sustainability updates. The <u>2022 T75 Sectors Status Update</u> presents a summary update on progress in each of the 13 seafood sectors toward the 75% goal, along with the latest trends in production and trade. Two new sector reports find that, while the reported production and trade of <u>octopus</u> and <u>mahi-mahi</u> have increased significantly in recent decades, a lack of data and inadequate regulations present a challenge to sustainable management of these fisheries.

SFP partners make broad commitments to seafood sustainability

Walmart announced that it will require all of its tuna suppliers to source exclusively from vessels with 100% electronic or human observer monitoring and from fisheries that use zero high seas transshipment (unless the activity is covered by 100% monitoring) by





As part of its SeaChange 2030 sustainability strategy, Thai Union announced that 100% of its wild-caught and farmed seafood will be produced responsibly or in an improvement program. The company also committed to support the protection and restoration of critical ecosystems, including mangroves and coral reefs. A recent report, produced by SFP and Thai Union, looks back at the first 18 months of our partnership.
